1. *Bosnia and Herzegovina* has received a grant from the International Bank for Reconstruction and Development (IBRD), acting as an Implementing Agency of the Global Environmental Facility (GEF), in various currencies towards the cost of *Adriatic Sea Environmental Pollution Control Project I*. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for *Procurement of Plant, Design, Supply, and Installation for treatment of leachate at the sanitary landfill „Uborak-Buđevci“ in Mostar*.

2. *J.P. "Deponija" d.o.o. Mostar* now invites sealed bids from eligible bidders for the construction and completion of Design, construction, installation, obtaining licenses, commissioning, proving the functionalities and maintenance treatment plant of leachate from the old and new landfill "Uborak". The project involves the treatment plant for leachate and at specific experience in the construction of solid waste landfill body along with a leachate collection basin. Installations must meet strictest requirements for the discharge of leachate into the surface flow of the Adriatic basin ("the Facilities"). International competitive bidding will be conducted in accordance with the Bank's Single-Stage Bidding Procedure.
